DUTIES & RESPONSIBILITIES

In addition to adhering to the general guidelines as specified by the Faculty/Staff Handbook, the AMSTI Director, Dean of Technical & Workforce Development, the President, and Alabama Community College System Board of Trustees, responsibilities will include the following:

- Assist in providing a Foundational Training that follows the ALSDE training requirements
- Provide frequent, ongoing, on-site assistance and coaching to AMSTI Schools (Note: The majority of specialists' work time is expected to be on-site support and coaching, including travel to and from the site. Specialists may assist with preparation for Foundational Training beginning with the spring state testing window.
- Provide training and guidance to AMSTI School lead teachers and instructional coaches
- Assist AMSTI Schools in effectively using common planning time and Professional Learning Communities/ Teams (PLCs) to improve math and science instruction
- Assist in developing a cadre of certified trainers to support current and future training programs
- Offer periodic professional learning to established AMSTI Schools
- Provide AMSTI-ALSDE approved professional learning to non-AMSTI schools in the region, as time permits

- Assist IHEs with pre-service and continuing education activities
- Assist with online course development and facilitation and web-related activities, as requested
- Attend professional learning activities and staff meetings conducted by the ALSDE, unless prior approval for absence is granted by the ALSDE
- Assist in recruiting new AMSTI Schools
- Provide input to the ALSDE regarding customization of kits and materials to make them teacher/classroom friendly
- Conduct research on the effects of current math, science, and technology practices in AMSTI Schools, as requested by the ALSDE
- Maintain records and complete paperwork in a timely manner (e.g., Google and Moodle, documentation required by IHE and ALSDE)
- Perform other duties assigned by the AMSTI Site Director or AMSTI-ALSDE the Dean of Technical & Workforce Development and the President.

3. A copy of transcript(s) verifying required degree. *Please print name as listed on transcript, if different from last name listed on application.*
4. Valid Alabama Teacher certification (T-cert) in Math, Science, or related field.
5. Work experience verification **in writing on company's letter head** from your current and/or previous employer(s) confirming the required level of experience as stated in the "Required Qualifications" section. Verification should include dates of employment and position title(s) and duties performed. If verification from current employer does not cover the **required** level of experience as stated in the "**Required Qualification**" section, verification from previous employer(s) will be required. **Remember that the work experience verification completion is your responsibility.**

Please Note: If you are applying for more than one position, please submit a separate, complete application. In the event the position is reposted, a new application packet must be submitted.
