## **INSTRUCTIONS:**

The applicant may hand-deliver the packet or send it by certified mail to ensure delivery. It is the responsibility of the applicant to review all documentation. All application packets received by the April 1<sup>st</sup> deadline will be reviewed by the scholarship committee to determine eligibility, and recipients will be notified in writing. Scholarships are awarded to first-time freshmen only and will cover tuition for a maximum of four (4) semesters does not include textbooks beginning with the fall semester.

## SCHOLARSHIP APPLICATION & REQUIREMENTS:

The following must be submitted as a complete application packet to the Scholarship Committee Chairperson by April 1<sup>st</sup>:

- 1. Copy of Acceptance Letter to WCCS
- 2. A legible copy of the applicant's academic transcript, including senior class first-semester grades.
- 3. Verification of applicant's ACT scores
- 4. Two typed letters of recommendation from non-relatives

### TYPES OF SCHOLARSHIPS:

- 1. Presidential Scholarship: Minimum ACT composite score of 24
- 2. Academic Scholarship: Minimum ACT composite score of 20
- 3. Technical Scholarship: Minimum 2.75 GPA
- 4. Certificate Scholarship: Minimum 2.75 GPA
